As a follow up to my previous message, the ITE California SB 743 Task Force has prepared and submitted a final comment letter on the draft SB 743 guidelines that were released by the California Governor's Office of Planning and Research (OPR) on January 20, 2016. The Western District has launched a "Close the Gap" campaign for the Student Endowment Fund goal of \$500,000. The fund reached the \$440,000 mark last summer and we need your help to close the gap. Legislative Analysis

Martin Varona, KOA Corporation

AB 1982: This bill amends the eligibility of traffic signal synchronization projects (TSSP) for Greenhouse Gas Reduction Funds by requiring that such TSSP projects move vehicles at an average speed of 12-15 mph in addition to the other provisions required for achieving cost effective reductions in greenhouse gas emissions.

AB 2509: Existing law requires cyclists on a roadway moving slower than the normal speed of traffic to ride as close as practicable to the right-hand curb or roadway edge with certain exceptions. This bill expands the allowable exceptions to Class I (path), II (lane), and IV (trackway) facilities.

Several transportation-related “spot” (preliminary) bills were introduced in February. The following bills will become more comprehensive as the Legislative Session progresses:

SB 1208: This bill pertains to the California Transportation Commission’s (CTC’s) authority to request reports and special studies on key transportation issues.

AB 1840: This bill deems bonds issued by the California Transportation Financing Authority for funding transportation projects tax exempt.

AB 2398: This bill expresses the Legislature’s intent to enact legislation pertaining to private funding for transportation projects.

Scribe Report

The ITE Southern California and Central Coast Sections held a joint meeting at the City of Thousand Oaks on Tuesday, February 9, 2016. This meeting opened with remarks from ITE Western District Treasurer/Secretary candidates Neelam Dorman and Jonathan Hofert. Ms. Dorman is currently serving as both the First Past President for the Southern California Section and the Career Guidance Chair for the Western District. Johnathan Hofert is currently serving as both the Past President and Webmaster for the Riverside/San Bernardino Section.

The presentation topic was “Erbes Road Improvements”. Clifford G. Finley and Dan Lazlo, both from the City of Thousand Oaks, discussed the project. The objective was to widen the road and install underground dry utilities. Project challenges included handling complex grading issues, dealing with

numerous oak trees, constructing retaining walls on steep slopes, handling complex easement and right of way acquisition issues, and continuously maintaining two lanes of vehicle traffic along this heavily traveled roadway. Effective leadership, teamwork, and public outreach practices led to the successful completion of this project and positive feedback from neighborhood residents.

TOD and SB 743 *David M. Schweigel, PE*

The ITE Western District is to be commended for a proactive response to the recent passage of SB 743 – the removal of Vehicle Level of Service (LOS) as a significance criteria in certain transit oriented development (TOD) areas. Here is some insight on the origin of SB 743 and some opportunities for further engagement on TOD and legislative topics.

On May 5, 2011, the California Pan Ethnic Health Network (CPEHN) (www.cpehn.org) and TransForm (www.transformca.org) collaborated to produce a Symposium at the California Endowment in Oakland entitled "The Road to Health: Transportation and Community Well-Being". A significant discussion point was while the reduction of vehicle speeds from 40 to 20 MPH degrades Vehicle LOS from A to C, it reduces pedestrian fatalities 10-fold.

During the October 2014 Envision California Summit in Sacramento, TransForm Executive Director Stuart Cohen explained how SB 743 was a collaborative effort to encourage alternate modes of transportation – namely walking, cycling, and transit riding in TOD areas to improve air quality and physical health.

During the May 2014 webinar of the ITE Sustainability Standing Committee, it was noted that Vehicle LOS may not necessarily be the "cure all to end all" in certain TOD areas, and there is value in customizable metrics to encourage the creation of complete streets and the safe and seamless interaction of multiple modes of transportation. It was also noted that San Francisco's Transbay Center (www.transbaycenter.org) redevelopment area achieved CEQA compliance via former Vehicle LOS metrics in 2010. Moving forward, as a result of the passage of SB 743, additional metrics for the

evaluation of impacts in TOD areas will be coming available, customizable by jurisdiction.

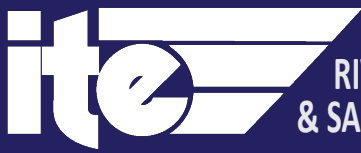

Moving San Diego and Los Angeles Forward

Marisa Mangan (SANDAG)

Marisa Mangan is a Regional Planner for SANDAG Department of Operations. Marisa coordinates transportation demand management (TDM) planning studies and supports local jurisdictions with TDM planning and policy development. She is also responsible for supporting the development and implementation of new and innovative TDM strategies like mobility hubs and the expansion of shared mobility services, a commitment in San Diego Forward: The Regional Plan. She currently serves as co-project manager for the development of a Regional Mobility Hub Implementation Strategy that will integrate shared mobility services to maximize existing and planned transit investments by reducing transit access barriers. Additionally, she supported the development of the SANDAG Regional Parking Management Toolbox, a resource that assists member agencies with shaping successful parking management programs to address the unique challenges of different communities.

Jay Kim (LADOT)

Jay W. Kim is the Assistant General Manager for Mobility Management at LADOT. He has over 26 years of transportation planning and engineering experience from both private and public sectors, including increasingly responsible management and leadership positions at LADOT. Mr. Kim was recently appointed to provide executive oversight for the planning and operation of transit, paratransit, shared mobility, on and off-street parking management, taxicab regulations and permits and to ensure that LADOT meets the goals of the Sustainable City Plan.

Mr. Kim is currently the Chair of the LADOT Complete Streets Committee along with active past participation in the Integrated Mobility Hubs Working Group, Downtown Street Standards Committee and Metro's Congestion Mitigation Fee Policy Advisory Committee.

♦ The Paradigm Shift of Our Transportation Industry, Carlos Ortiz (Connected Vehicle Technology)

Mr. Ortiz is the Chief Operating Officer for ADVANTEC Consulting Engineers. He has extensive experience managing Intelligent Transportation System (ITS) projects for numerous agencies throughout California. Through his current projects, Mr. Ortiz is assisting agencies to understand the Smart Cities and Connected Vehicles and Autonomous Vehicles markets so they can make better decisions on current and future ITS deployments.

Recently, Mr. Ortiz was appointed by ITE's current International President, Ms. Paula Benway-Flores, on the ITE Strategic Initiatives Committee, an international committee that will define the new role of ITE as our transportation industry continues to change rapidly. ♦ What's Coming with the California Road Charge Pilot Program, Martin Wachs (UCLA)

Martin Wachs is Distinguished Professor Emeritus of Civil & Environmental Engineering and of City & Regional Planning at UC Berkeley, where he directed the Institute of Transportation Studies and the University of California Transportation Center. After retiring from the University, Dr. Wachs became the Director of the Transportation, Space, and Technology Program at the RAND Corporation in Santa Monica. He is now semi-retired, teaching courses and conducting research at UCLA in transportation policy and working on transportation policy projects at RAND.

Dr. Wachs was Transportation Policy Advisor to Los Angeles Mayor Richard Riordan and was appointed by Governor Pete Wilson to a "Blue Ribbon Commission on California Infrastructure." He currently serves on a statewide committee created by the legislature to design a new system of road user charges for California to succeed the motor fuels tax and recently was appointed by the Controller of the State of California to the Peer Review Group of the California High Speed Rail program.
