Positioning Yourself on the Leading Edge of Transportation Developments

Our transportation industry is ever changing. How can transportation professionals keep abreast of the latest development in best practices? As an ITE member, you can join ITE Councils, and help achieve the *ITE Strategic Plan's* "Big Audacious Goal" to bring together transportation's body of knowledge and professional voice for the benefit of society. Membership in two Councils is free, with one from the employer-type category (Public Agency, Transportation Consultant, and Transportation Education) and one Council from the technical category.

Among the nine technical Councils is the Management & Operations/ITS Council. This Council actively spotlights best practices for consideration by members. The Council mission is to promote dialogue and innovation in deployment of transportation solutions that maximize the use of existing infrastructure to benefit society. The goal is to be a professional voice in marketing M&O/ITS so that it is viewed as equal in importance with project design and construction. Council members are positioned on the leading edge of issues through newsletters and special mailings that cover emerging trends, proposed legislation and regulation, as well as participate in Internet discussion groups and other council sponsored activities.

For example, the Fall newsletter will summarize the recent National Conference of State Legislatures report, "*ON THE MOVE – State Strategies for 21st Century Transportation Solutions*". This report lauds Transportation Management & Operations, as it explores innovative surface transportation reform laws, policies and programs to take the nation's transportation system well into the 21st century. And it includes information that M&O/ITS professionals can use as we seize our opportunities to be the professional voice.

Talking points are presented on ways that M&O/ITS can be linked to promoting fiscal and environmental sustainability; facilitating affordable, safe and accessible transportation choices; and achieving shared benefits such as improved public health and economic development. Members are positioned to use this report to communicate how M&O/ITS:

- Enhances system performance for both motorists and transit users, without costly new construction.
- Enables low-cost, low-impact and easy to implement solutions, with high benefit-cost ratios and both short- and long term benefits.
- Delivers improved day-to-day performance by managing travel demand and system access.
- Reduces recurring traffic jams through highway management and use of ITS advanced technologies.
- Mitigates occasional congestion due to traffic accidents, work zones, weather and special events.
- Streamlines freight transportation through relevant technologies.

Recommended best practices will be featured through Council sponsored sessions at the March 3 – 6, 2013 Technical Meeting in San Diego. An ideally timed session is preliminarily titled "*Integrated Corridor Management – Going Live in San Diego*". This session is proposed to spotlight the multimodal integration of traffic management along arterial and freeway corridors, which is scheduled to "go live" around our conference time frame. Under consideration is a tour where participants ride light-rail from the Convention Center to Interstate 15, transfer to a bus and ride the HOV/HOT lanes of I-15, and exit a Transitway interchange to one of the transit centers built to encourage transit mode shift. This session would also address the travel time information sharing that will enable informed travel choices in San Diego, and that can be considered for replication in other regions.

US High Speed Rail Association Conference

The US High Speed Rail Association (USHSR) (www.ushsr.com) – the nation's "only nonprofit advocating for a nationwide High Speed Rail network to be constructed in phases between now and 2030" – is holding a Southern California Conference

Monday December 3 – Wednesday December 5, 2012
Los Angeles Union Station

USHSR held June 2010 Los Angeles and May 2012 San Francisco Conferences. Governor Jerry Brown signed initial California High Speed Rail Project (www.cahighspeedrail.ca.gov) funding into law in July 2012. Now what? The December 2012 Conference sheds some light on this subject.

California High Speed Rail is a "go." Now what?

In July, Governor Jerry Brown signed initial funding for the California High Speed Rail project (www.cahighspeedrail.ca.gov) into law after Assembly (51-27) and Senate (21-19) approval. Now what? The project is California's largest ever infrastructure endeavor and America's largest infrastructure endeavor since the Interstate Highway System.

Is this still the "Great White Pumpkin Charlie Brown?"

Project supporters are sometimes viewed as "Linus," (waiting all night with Sally for an extraordinary magical pumpkin that never came) preaching about a "pipe dream" that won't happen. The July 6, 2012 *Sacramento Bee* front page shows Senate President Pro Tem Darrell Steinberg's relieved yet exhausted reaction: "With all 15 Republicans and 4 of the Democrats opposed, there was no room to spare...had to get everybody else," in the toughest vote of his career - successful in securing initial funding (\$6 B between Madera and Bakersfield plus \$2 B in Bay Area and Los Angeles "bookends")

Do "storm clouds" still lie ahead?

Voters approved Proposition 1A (HSR project) in November 2008 based on a \$45 B quote. Yet a recent field poll shows, if given a re-vote today, the vast majority would vote it down due to cost escalation. The November 2011 *Business Plan* ballooned the quote to \$98.5 B. The April 2012 *Business Plan's* "blended system" reduced the quote to \$68.4 B. Yet across the board State budget cuts still make voters wonder "Is the Governor's legacy HSR project luxury spending in lean times?"

Does the message need re-crafting prior to the Prop 30 Vote in November?

In his efforts to pass Proposition 30 (tax increases to reduce the budget deficit from \$14 B to \$8 B) in November in the wake of signed HSR legislation, Governor Brown is viewed as "the father who lets his children starve while he buys a Cadillac" ("A lot riding on California dream of high-speed rail," by Daniel Woods, *Christian Science Monitor*, August 21, 2012). Re-crafting the message as "the Golden Opportunity for the Golden State to stimulate our economy" entails demonstrating immediate benefits in the San Francisco (Caltrain electrification) and Los Angeles Basin (Metrolink upgrades) "bookends." Governor Brown also needs strong performance on Construction Package 1 (Ave 17 (Madera) to East American Ave (Fresno)) currently being bid on by 5 pre-qualified design-build enterprises: California Backbone Builders (www.californiabackbonebuilders.com), California High Speed Rail Partners (www.chsrpartners.com), California High Speed Ventures (www.highspeedventures.com), Dragados/Samsung/Pulice (www.dragados-samsung-pulice.com), and Tutor Perini/Zachry/Parsons (www.tutorperiniparsons.com). Unsuccessful bidders are free to pursue Packages 2 (East American Ave (Fresno) to Lansing Ave (between Hanford and Corcoran)), 3 (Lansing Ave (between Hanford and Corcoran) and Perkins Ave/Elmo Hwy (north of Wasco)), 4 (Perkins Ave/Elmo Hwy (north of Wasco) to Bakersfield – variable length depending on how far funding goes), and 5 (rails along entire length). The "paved paradise and put up a parking lot" message of the 60's (20% of California's budget spent on infrastructure) degraded our profession's prestige so much that by the 80's, only 1% of California's budget went to infrastructure (*ASCE California 2012 Report Card*). ASCE (www.asce.org) discovered that 100+ page infrastructure report cards alone are not enough to re-ignite heavy infrastructure spending (\$470 B in unmet transportation needs in California over the next 10 years), so they are soliciting success stories.

Is this just about HSR?

At the US High Speed Rail Association (USHSR) (www.ushsr.com) May 2012 San Francisco Conference, in his "Statewide TOD Vision" (www.visioncalifornia.org) presentation, Peter Calthorpe noted that HSR is the "backbone that knits all these (transportation choices) pieces together."

Is this anti cars and planes?

HSR is about a “balanced transportation system,” with passenger cars and flex-cars playing an important role beyond the Transit Oriented Development (TOD) station-to-door service, and planes as a principal carrier for journeys greater than 600 miles. San Francisco International Airport (SFO) is a strong HSR strongest supporter with the SFO HSR station improving passengers’ ability to get to the airport to take higher profit margin long-haul (greater than 600 miles) flights via de-cluttered airways free of lower profit margin short-haul (less than 600 miles) flights.

How can we unite supporters and opponents?

Some buy into the “train to nowhere” and “California can’t afford it” messages. Others like the HSR idea, but disagree with the implementation. Build alliances on common ground elements like boosted infrastructure spending and improved mobility.

What about Republicans?

USHSR reminds us to message public private partnerships that capitalize on public sector risk and private sector innovation. Republicans traditionally oppose large government (public sector), so beef up the private sector’s role.

What about education?

Check out USHSR (www.ushsr.com) May 2012 San Francisco conference presentations and educational materials. Consider attending their December 3 (Mon) – 5 (Wed) 2012 Los Angeles Conference at Union Station.

Check out California High Speed Rail Authority (www.cahighspeedrail.ca.gov) published (Business Plan, Strategic Energy Plan) and endorsed (Urban Transportation Planning Principles) works.

Why should we “educate” instead of “cheerlead?”

The “American Dream” (suburban housing) and the separation of land uses has propagated our “auto oriented culture” (“Great American Streetcar Scandal” of auto interests dismantling streetcars) so much that messages among the car interests (wanting Americans to consume as much oil as possible) remain mainstream, leaving HSR messages (*Fast Trains: America’s High Speed Future* by Emy Louie, May 21, 2012) (www.fasttrainsbook.com) few and far between. Instead of forcing a “pro HSR stance,” let them know

your role is to educate them on both sides of the issue, so they can make an informed decision.

What’s California’s Role in Nationwide HSR?

Hill & Knowlton Public Affairs notes, “If a trend starts in California, it quickly propagates to the rest of the nation.” Serve as an expert on HSR, mode interconnectivity, and Transit Oriented Development (TOD), as ITE revises single-suburban-use trip generation manuals to be more reflective of mixed-use walk-able urbanism. Of particular interest: (1) one size does not fit all, (2) aesthetics (artwork, landscaping, water features, decorative lighting) count, and (3) pedestrian and cycling activity should be promoted over auto-oriented activity (minimal large surface parking lots and service stations) in the pedestrian-oriented environment. Another fascinating concept is “crime reduction through urban design.” Check it out by Googling “Urban Transit Design Guidelines.”
